

### Conditions of Participation for PORSCHE EXPERIENCE Track Visit (Version 05/2019)

#### 1. Scope of Application

Based on a contract with Dr. Ing. h.c. F. Porsche AG, SPORTTOTAL EVENT GmbH (hereinafter referred to as PORSCHE EXPERIENCE) is authorised to provide certain tours and other events under the designation 'Porsche Experience'. These conditions apply to participation in the PORSCHE EXPERIENCE Track Visit (hereinafter referred to as Track Visit).

#### 2. Booking

The Track Visit is booked via the PORSCHE EXPERIENCE website. A contract is concluded via the online booking and a corresponding confirmation is sent by e-mail from PORSCHE EXPERIENCE. Participants may only make a booking in their own name. The transfer of bookings, bookings in a third-party name or commercial bookings require the express consent of PORSCHE EXPERIENCE.

Participation in the Track Visit is free of charge and includes a visit to the respective event without any actual driving. The minimum age for participation is 18 years.

#### 3. Cancellation

The smooth running of the PORSCHE EXPERIENCE event has absolute priority over the Track Visit. PORSCHE EXPERIENCE therefore reserves the right to change or cancel the Track Visit due to weather conditions, safety-related incidents, operational reasons or official orders. In the event of a cancellation, PORSCHE EXPERIENCE will try to offer an alternative date.

PORSCHE EXPERIENCE is entitled to cancel the Track Visit at or after the start of the event if the proper execution of the event is endangered or rendered impossible due to the behaviour of the group or individual participants.

#### 4. Proper Execution of the Event

Proper execution of the Track Visit is only possible if participants arrive punctually at the location specified in the confirmation e-mail. In the event of delays of more than 15 minutes, the visit cannot be guaranteed.

#### 5. Liability

PORSCHE EXPERIENCE accepts no liability for any damages arising from the cancellation or the interruption, modification or termination of the Track Visit. Furthermore, the liability of PORSCHE EXPERIENCE is limited to intent or gross negligence, insofar as a possible breach of duty regarding the Track Visit does not affect the main contractual obligations of PORSCHE EXPERIENCE or participant claims arising from loss of life, personal injury or damage to the health of the participant.

### 6. Participants with Reduced Mobility

We recommend that participants with reduced mobility are accompanied, as the PORSCHE EXPERIENCE service staff are unable to provide the appropriate support. Participants with reduced mobility are requested to state this when making the booking and to inform PORSCHE EXPERIENCE in advance of any wheelchairs and other aids, in particular.

### 7. Safety Instructions

It is forbidden to bring along any prohibited objects such as pyrotechnic equipment, drones or similar flying devices. In addition, further conditions of use may apply at the respective venues. It is forbidden to enter any areas that have not been authorised for the Track Visit.

Animals are not permitted to accompany participants on the Track Visit.

The instructions of the PORSCHE EXPERIENCE staff must be followed. In the event of a violation, PORSCHE EXPERIENCE is entitled to exclude the respective participant from the event.
